### Senate Order for Entity Contracts Listing relating to the period 1 January 2020 – 31 December 2020

#### Senate Order

Pursuant to the Senate Order for entity contracts, the following table sets out contracts entered into by Export Finance Australia which provide for a consideration to the value of A\$100,000 or more (GST inclusive) and which:

- (a) have not been fully performed as at 31 December 2020; or
- (b) which have been entered into during the 12 months prior to 31 December 2020.

Details of some contracts include amounts invoiced by Export Finance Australia but attributable to services provided by Export Finance Australia as part of its function to assist other Commonwealth entities or companies. While Export Finance Australia is the contracting entity, such amounts are fully recoverable from these other entities.
