Senate Order

This is the Senate Order for Entity Contracts listing relating to the period 1 July 2022 to 30 June 2023. Pursuant to the Senate Order for entity contracts, the following table sets out contracts entered into by Export Finance Australia which provide for a consideration to the value of A\$100,000 or more (GST inclusive) and which:

- have not been fully performed as at 30 June 2023;¹ or
- which have been entered into during the 12 months prior to 30 June 2023.

Contracts where Export Finance Australia is the contracting entity are included, even where Export Finance Australia is contracting to obtain goods or services as part of its function to assist other Commonwealth entities. While Export Finance Australia is the contracting entity, the extent of any such amounts attributable to this function of ours is fully recoverable from these other entities. As such, there may be some duplication of amounts reported below (incorporated also within the relevant Commonwealth entity service fee as a recoverable cost).

Similarly, transaction related costs are included below where Export Finance Australia is the contracting party, even where amounts are recoverable from another party such as our customer.
